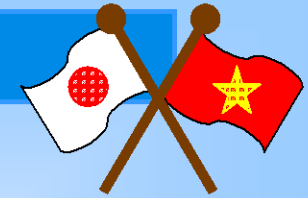
Testing Law and Judiciary through Dispute Processing

- Fair and Effective Judiciary is a key for sustainable business and market – proper implementation of law
公正有効な司法による法執行は持続可能なビジネスの鍵
- Arbitration will bridge the gap between global standard and Vietnam's local practice – Vietnamese law applied / interpreted by foreign arbitrators
外国人仲裁人の越法適用による仲裁は国際標準と現地実務の溝を埋める
- Japanese experiences would be useful to harmonize such gap: conciliatory culture v. adversarial culture – combination of arbitration and mediation/conciliation
- 調停文化／調停と対抗的文化／仲裁の溝を埋め調和させる日本の経験₅

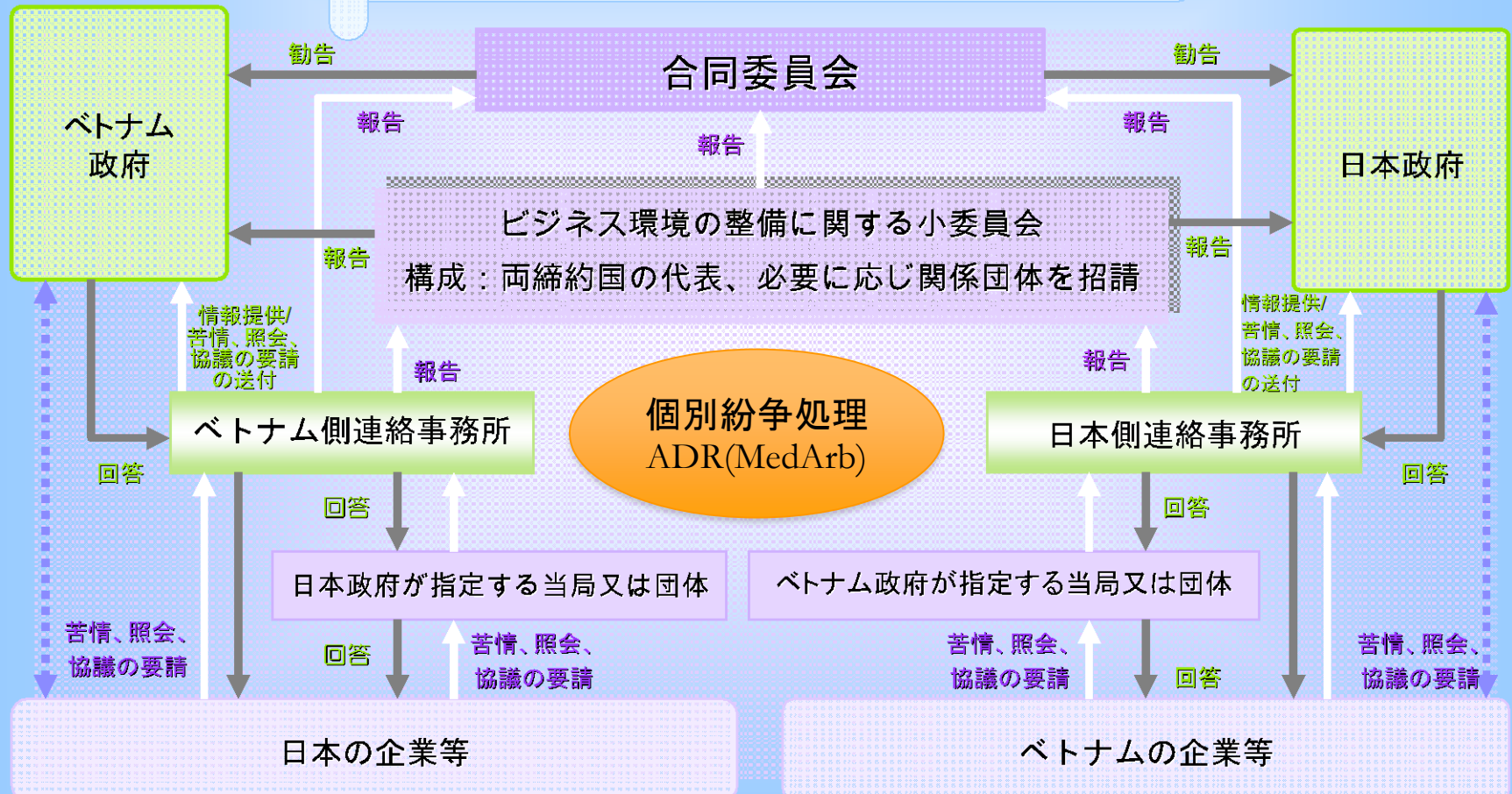
Network Group for JVEPAADR

- Arbitration is a universal mechanism not only for commercial dispute, but also territorial ones b/n states as well as investment disputes (ICSID; ISDS in TPP)
仲裁は商事紛争だけでなく、投資紛争や国境紛争など国際紛争にも有効
- Human Resource Development in arbitration and mediation is crucial in not only lawyers and arbitrators, but also judges, business managers and officials – international competition

- VIAC-JCAA/JIDRC/JIMC-VJU network to set up JVEPAADR 設置のためのネットワークグループ形成

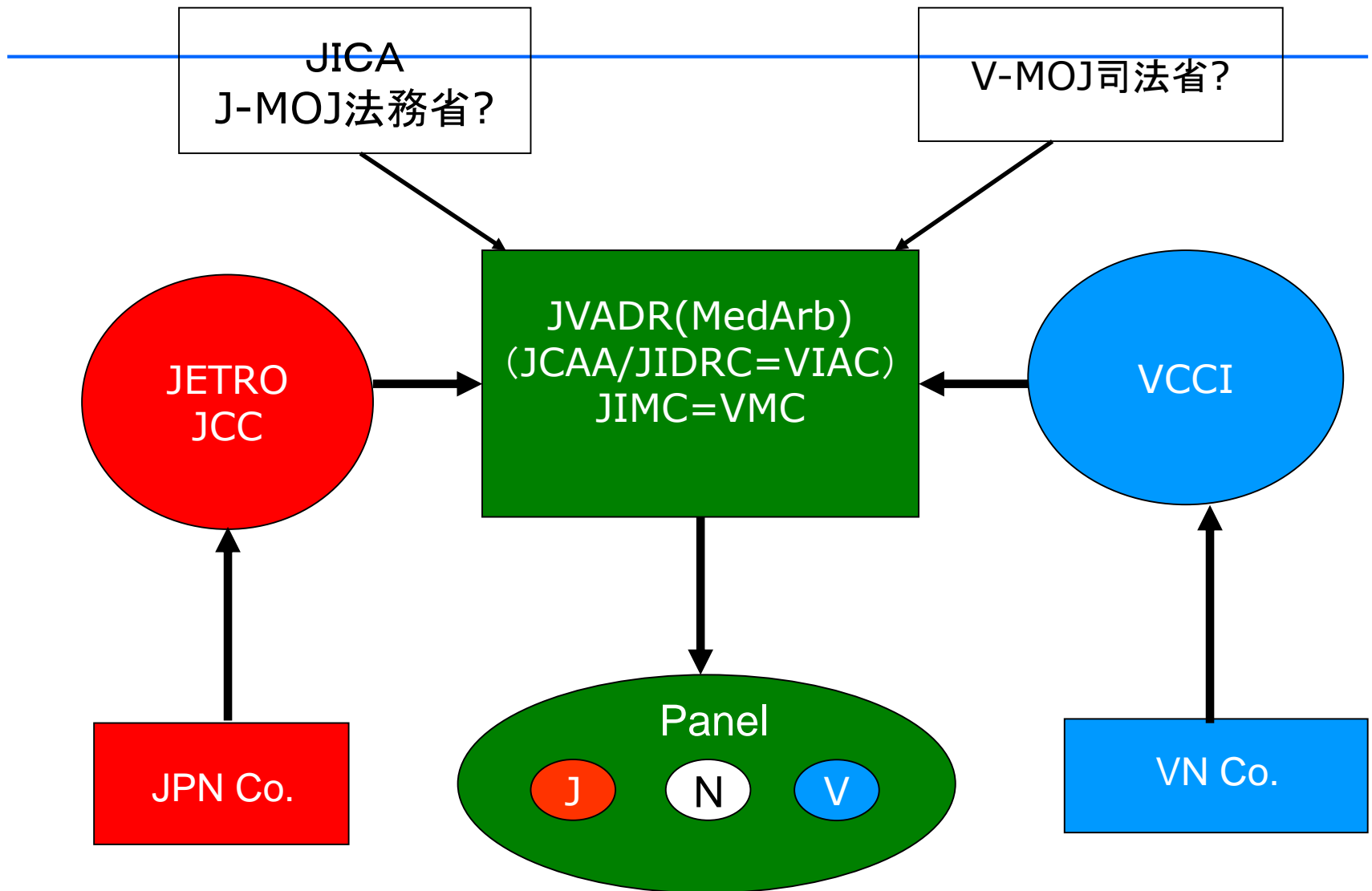
